Nominations for Officers and Delegates to AZ State Convention

This is notice to members of NALC Branch 704 that nominations for Officers for the positions of President, Vice President, Recording Secretary, Financial Secretary, Treasurer, Sergeant At Arms, Health Benefits Representative, Retiree Representative, Five (5) Trustee positions and Delegates to the 2021 AZ State Biennial Convention shall be taken at the regular meeting of NALC Branch 704 October 01, 2020, beginning promptly at 7:00 p.m. at NALC Branch 704, located at 2950 North Country Club Road, Tucson, AZ. Successfully elected Officers shall serve a 3-year term; successfully elected Delegates shall serve a 2-year term until election of Delegates to the subsequent State Convention. Nominations shall be conducted by floor nomination for Officers and Delegates by sign-in roster and accepted from the floor during the meeting, mail-in nomination received prior to the October 1st meeting addressed to the Recording Secretary of NALC Branch 704 for all absentees. Election shall be by mail-out ballot for all eligible members properly nominated for contested Officer positions. In the positions of Delegate if the number of proper nominations exceeds the amount of authorized Delegates, a mail-out ballot shall be conducted. In the event of the necessity of a mail-out ballot, ballots shall be mailed to the members last known address, those members requesting absentee ballots (mailed to a different address) shall make a written request to the NALC Branch 704 Election Committee at 2950 N. Country Club Road, Tucson, AZ 85716-1912, no later than 14 days prior to election but after nominations have closed. Each person nominated must verify in writing that they have not served, applied, or acted in a supervisory capacity of the Postal Service for twenty-four (24) months prior to the election.

In the event that the COVID-19 pandemic and the social-gathering guidelines from the CDC are still active, and we are unable to have a regular branch meeting in October, nominations will be conducted by mail-in nomination and must be received prior to October 1st. The membership will be notified via the September Newsletter of the status of the October Branch Meeting/Nominations.

President's Report

Dear Brothers and Sisters.

USPS covid-19 cases are as follows: All employees positive total 36.576/Employees returned to work 27,850/Employees out of work 8,726/Employees that were positive and returned to work 3,268/ Employees unconfirmed and out of work 640/Employees positive and out of work 2,365/Employees passed away total 73/City Carriers 15.

The Arizona District has confirmed 172 Covid-19 employees and are tracking 222 employees. Tucson has 12 confirmed covid-19 employees and tracking 26 employees. Last week unfortunately the Arizona District had 2 EAS employees that died, a Postmaster in Phoenix and EAS Gail Giannantonio Bulk Mail in Tucson. Our thoughts and prayers are with them and their families.

I have witnessed a lot more employees wearing masks and being more cautious at the stations, but there are still employees taking chances not only with themselves but putting other employees at risk of contracting the virus. We have been blessed in Tucson not having more employees affected. Unfortunately, I hear all too frequently about employees having to attend a funeral service for a family member. Being careful at work will protect not only your co-workers but also your families and wearing a mask and washing your hands is a small price to ensure the safety of a loved one. Having to live with the remorse of the thought, "if only I had worn a mask or been more careful" is not what I would want for you or me. Let us all practice social distancing when around other persons and wear a mask.

An article in the Postal Times was printed concerning the new PMG and his expectation and plans for USPS. The article states he wants to eliminate POT and OT used, among other ideas for the post office to cut cost or eliminate from the post office. Whether the PMG's ideas will fix the post office will remain to be seen, my concern is the PMG has never been a USPS rank and file employee, which means he will have perceptions not facts of what we do each day.

Our own customers sometime believe a carrier's job is easy when they don't know what our job really entails. It's hard to believe the PMG will have all the information he will need to make changes that do not consist on number crunching only and customer service will be sacrificed along with parts of our contract.

So not surprising Tucson Management is already moving to cut times on a carrier's route, by instructing carriers to leave by 9:00am regardless if you came in group one 7:45 or group two 8:15am. You as the professional city carrier should provide an estimate of your daily workload that determines how much time you will need to do your route. Management numbers are not what determines your workload time on your route.

MOU-01664 states in part: The Delivery Operations Information System (DOIS) is a management tool for estimating a carrier's daily workload. The use of DOIS does not change the letter carrier's reporting requirements outlined in section 131.4 of Handbook M-41, the supervisor's scheduling responsibilities outlined in section 122 of Handbook M-39, or the letter carrier's and supervisor's responsibilities contained in Section 28 of Handbook M-41. DOIS projections are not the sole determinant of a carrier's leaving or return time, or daily workload. As such, the projections cannot be used as the sole basis for corrective action.

If you have mail and need more time to case and pull down than 1:15 minutes or :45 minutes they say you have, let management know so they can tell you what to do, weather continue to case the mail or curtail the mail.

Should Management instruct you curtail mail you have to fill out PS Form 1571 (Undelivered Mail Report) before leaving the office with amount of mail curtailed, leave PS Form 1571 with curtailed mail. When you return from the street any mail which was not delivered add to the PS Form 1571. sign and give to manager. "Never curtail mail un-President Article (Cont. on pg. 3)

President Article (Cont. from pg. 2) **less instructed to do so by management.**" Upon request a duplicate of the completed PS Form 1571 will be provided to carrier. If you are not given the

request a duplicate of the completed PS Form 15/1 will be provided to carrier. If you are not given the opportunity to work your route as bid, ask to speak to a steward. Be prepared with statements of what happened.

The Region 4 Rap Session scheduled 9/24/20 was formally canceled by NBA Dan Versluis due to rise in positive tests and renewed social distancing requirements in every state of our region.

Brothers and Sisters let me start out by saying I hope you are doing well and staying safe. All too often I see various individuals, be it my fellow colleagues on the workroom floor or members of the general public not adhering to what is now mandated in the city of Tucson and Pima county.

Sure, we deliver to over 158 million businesses and residences. And yes, we deliver four million Prescriptions to customers, each and every day (seven days).

Health Benefit Report What Your First-Aid Kit Should Contain

- Absorbent compress dressings to help stop bleeding.
- Adhesive cloth tape to hold compress dressings in place.
- 3. Adhesive bandages of assorted sizes.
- 4. Antibiotic ointment, such as bacitracin, polysporin, or mupirocin.
- 5. Antiseptic solution or wipes, such as hydrogen peroxide, povidone-iodine, or chlorhexidine.
- 6. Aspirin in the event of a heart attack.
- 7. Instant cold compress.
- 8. Nonlatex gloves.
- 9. Hydrocortisone ointment.
- 10. Three-and 4-inch gauze bandages to wrap injuries.
- 11. Box of sterile gauze pads for sterile wound dressings.
- Triangular bandage to use as a bandage or tourniquet.
- 13. Oral thermometer.
- 14. Tweezers.
- 15. CPR mask, which can be used to administer CPR

without breathing in another person's bodily fluids.

You may also want to have petroleum jelly, pain relievers, such as acetaminophen (Tylenol and generic) and antihistamines like diphenhydramine (Benadryl and generic). Be alert for side effects with antihistamines.

Note:

Because COVID-19 can cause low blood oxygen, you may be wondering whether you should have a home pulse oximeter, a device typically worn on the finger to check levels of oxygen in the blood. If you decide to purchase one, note that a 2016 study found that some home models were more error-prone than oximeters that doctors use. If you have symptoms that could be COVID-19, pay attention for short-ness of breath, and alert your doctor right away if it occurs.

Contract Talk

Q: Can I use Bereavement Leave for the death of my Brother-in-law?

A: City Letter Carriers may use a total of up to three (3) workdays of annual leave, sick leave or leave without pay, to make arrangements necessitated by the death of the family member or to attend the funeral of a family member.

Authorization of leave beyond three (3) workdays is subject to the conditions and requirements of Article 10 of the National Agreement, subsection 510 of the Employee and Labor Relations Manual and the applicable local Memorandum of Understanding provisions.

Q: What is the definition of Family Member?

A: "Family Member" is defined as a:

- a) Son or daughter—a biological or adopted child, stepchild, daughter-in-law or sonin-law;
- b) Spouse;
- c) Parent; or
- d) Sibling—brother, sister, brother-in-law or sister-in-law; or
- e) Grandparent.

Q: Can I use the 12 weeks together or separately that the USPS gives for the COVID-19 to take care of my children who are out of school?

A: Based on the MOU, all 12 weeks are to be taken at one time, but local management will work with carriers if they want to split the times off with their spouse to be able to spread the 12 weeks.

M-01910 - March 18, 2020 - NALC and the Postal Service have agreed to a Memorandum of Understanding (MOU) allowing a temporary expansion of sick leave for dependent care due to the COVID-19 pandemic for 60 days beginning March 18, employees may use sick leave

for dependent care in the event they must care for a child as a result of daycare closures, school (pre-K through Grade 12) closures, or the unavailability of a child's primary caregiver as a result of the COVID-19 pandemic. The MOU does not change the 80-hour limit for this category of leave that may be used in any leave year.

With the signing of M-01924, this MOU-01910 was extended through September 25, 2020.

Q: Are letter carriers going to have the hazard pay for essential workers even if the HEROES Act is not approved?

A: The HEROES Act, which passed the House in May includes \$25 million in direct funding to the Postal Service and would repeal restrictions on the \$10 billion line of credit that was authorized by the CARES Act. Unlike the Senate Bill, the House HEROES Act also contains a hazard pay provision that would include letter carriers.

There is support from Senate Republicans to pass another Stimulus, but we must do our part. Please continue to encourage your family, friends and neighbors to go to www.HeroesDelivering.com to help convince our representatives. You can help also by going to Government Affairs on NALC.org and take action, which will take you to a link to have your voice heard.

We must all work together to help pass the HEROES Act if we want to have hazard pay for essential workers along with Stimulus money for the Postal Service.
