Formal Step-A Report

During the month of October 38 grievances were resolved at the Formal Step-A level. A summary of the settled grievances is listed below:

FORMAL STEP-A:

- Settled **4** Letters of Warning (LOW) by getting 2 reduced to a 2-month LOW, 1 reduced to a 4-month LOW and 1 reduced to a 6-month LOW.
- Settled **4** 7-Day Suspensions getting 2 reduced to an official discussion, 1 reduced to a 3-month LOW and 1 reduced to an 8-month LOW.
- Settled **1** grievance where a 204b was in a higher-level status for more than 120 days by pulling that 204b's bid position and having that job posted on the next bid cycle.
- Settled 12 grievances where management failed to send reserve carrier to their home station after a long term opt ended by getting that carrier paid a 50% premium for all hours worked off assignment and carriers who should have performed the work paid for those hours (Total \$4,846.97).
- Settled 8 grievances where management improperly forced non-ODL carriers to work overtime by getting those carriers paid the appropriate premium payment and ODL carriers paid for the missed opportunities (Total: \$2,001.26).
- Settled **3** grievances where RCAs were performing City Carrier work delivering Amazon parcels by getting the carriers who should have done the work paid. (Total \$1,112.45)
- Settled 1 grievance where management was performing bargaining unit work by getting those carriers who should have done the work paid (Total \$363.43)
- Settled 5 grievances where management failed to post vacant bid assignments in a timely manner by getting the successful bidders or assigned carriers of those routes paid \$250.00 each (Total \$6,250.00)

We received 1 Arbitration award in October. The Arbitrator ruled management did not have just cause to issue the carrier a Notice of Removal and reduced the removal to a 14-day Suspension. The Arbitrator further awarded the carrier full back pay and benefits for time in a non-pay status approximately (Total \$29,062.00)

Management's failure to follow the contract at the Formal A cost the USPS \$14,574.16 this month.

Management's failure to follow the contract at the Informal A cost the USPS \$ 7514,23 this month.

Management's failure to follow the contract cost the USPS \$ **51,150.39** this month.

There are 58 grievances outstanding at Formal Step-A.

Health Benefit Report Know Your Numbers

When your heart has to work harder to pump blood through your body, it can have a negative impact on your health. Over time, high blood pressure can cause your heart to enlarge and make your arteries less flexible. According to the Centers for Disease Control and Prevention (CDC), about one in three adults in the US has high blood pressure, which increases the risk for heart disease and stroke—two of the leading causes of death in the US. Remember, high blood pressure usually has no symptoms. So, it's important to have your blood pressure checked by your doctor and know your numbers.

Your blood pressure consists of two numbers: Systolic and diastolic

- ✗ The systolic number shows how hard the blood pushes when the heart is pumping.
- ✗ The diastolic number shows how hard the blood pushes between heartbeats, when the heart is relaxed and filling with blood.

If your reading is 120 (systolic)/80 (diastolic) or higher you could be at risk for high blood pressure

You can help manage your blood pressure by taking an active role in your health.

Did you know that by making changes to your lifestyle such as eating a healthy diet, maintaining a healthy weigh, exercising, not smoking and limiting alcohol intake can help lower your blood pressure? But sometimes lifestyle changes are not enough. Your doctor may recommend medication to lower your blood pressure. It is very important to take your high blood pressure medication as prescribed by your doctor.

Contract Talk

Q: I am a CCA on an opt. Can I be taken off the opt?

A: Yes, but only if it is to provide a regular carrier 8 hours of work. This can be up to 8 hours. Management needs to be sure there is no overtime that could have been carried by a regular carrier at straight time. Ref: Article 41.2.B.4 & .5, JCAM pgs. 41-9 – 41-17

Q: When on an opt, can management change the non-schedule day of the opt?

A: No, management cannot switch days off to avoid overtime or any other such reason. If this happens, see your union steward.

Q: As an ODL carrier working my non-scheduled day, what route do I carry?

A: The LMOU states that any regular carrier brought in on their non-scheduled shall displace the T-6 and carry their route only if there is an opening on their string of assignment. If no route is vacant that day, you may be assigned as needed. As for a T-6 on their nonscheduled day, they can be assigned as needed, but not displace any one.

Q: Can a T-6 be displaced by a regular carrier who is unassigned or has an opt?

A: No, again according to the LMOU, the T-6 can only be displaced if the <u>regular</u> is brought in on their N/S day and there is a vacant route on the T-6 string. Any carrier on an opt is not the regular carrier. Again, see your union steward if this is happening.

Q: Can a work assignment carrier get their overtime taken away?

A: Yes, but only in certain circumstances. A CCA or PTF can carry their overtime at straight time or regular overtime rate. A regular carrier can also carry W/A overtime only if they are on straight time.

ODL carriers can also be assigned W/A overtime to prevent the W/A carrier from going into penalty if the ODL will not be going into penalty overtime. Otherwise the overtime should be assigned to the W/A carrier up to 10 hours or 12 hours. Ref: Article 8.5, JCAM pgs. 8-21 - 8-22 & 8-30 - 8-31.

If you think your opting rights are being violated or not working your assignments, see your union steward as soon as possible.
