## **President's Report**

Dear Brothers and Sisters.

The holiday season is upon us and with it holiday mail including more SPRs and parcels to deliver daily. Customers are expecting to receive packages from family and friends, or they have ordered all their holiday gifts through the mail. Making sure all mail gets to the proper house with the least amount of damage goes a long way to a customer's image of the letter carrier; take the time to deliver the mail or parcels properly. I would like to remind everyone that customers have cameras at their homes to see who comes to their door and what happens to their packages. Don't be the carrier on YouTube throwing parcels over the fence or tossing it to the door. Take the time necessary to deliver the mail as we are required to in the M-41.

In Tucson we have improved the Backing of the LLV over 50 feet significantly from when we started. I would like to remind everyone to only back up in the LLV when it's absolutely necessary and avoid backing up whenever possible. If you can, park where you will not have to back up to pull away from a parking place. If you must back up, first walk around your vehicle to make sure there are no pedestrians, children, obstructions, etc., in your way. If you miss a parcel or mail piece stop the LLV, turn the engine off, and dismount from the vehicle and walk back to deliver the mail piece or parcel. If you are called to an investigative meeting with management request for your steward to be present. We are receiving grievances at the Formal-A and they are being settled. Providing a statement of what happened or did not happen concerning the backing is important to be able to argue your case at Formal-A, so write a statement for your steward.

At the December branch meeting, Dan Versluis was awarded the Outstanding Member of NALC Branch 704. This is awarded to members that have distinguished themselves with work done for the branch and its members. Dan has been doing work for us since 1994 when he became the shop steward and has continued to the present. Now that he has become the National Business Agent for Region 4, he is still involved in providing the branch with help and information with a class for CCAs and a class for carriers interested in Retirement. Because of Dan's hard work, the branch is in a good

financial position to continue providing members with the representation the Union is known for, and the education Dan has made a priority to give to stewards and its members. Because of this and all the time and effort he has given to the members, he is the Outstanding Member of NALC Branch 704. Congratulations Dan!!!

Branch 576 in Phoenix will have a Retirement Seminar January 26, 2020 for those members that were not able to attend the October Retirement Seminar we had at the branch; this is your chance to attend. Branch 576 will pro-vide breakfast, so if you want to attend, please call us and let the Union know so we can give them a count of individuals that will be attending.

The Retiree Luncheon was great! We had 105 retirees attend the luncheon and our guest speaker was NBA, Dan Versluis. I was very pleased to visit with our retirees and have the opportunity to present the pins for their years as a union member and Gold Cards to members that have reached 50 years. It's because of their membership and activism throughout the years that we active members enjoy the benefits we have. Without them working in the union and providing support to our issues we would not have the best union in the Post Office. I also want to acknowledge all the retirees that help in the branch whether it's helping with the newsletter or picketing for US Mail Not For Sale, without your participation our branch would not be as successful as it is. Thank you for all your work and support to the branch office.

As letter carriers know, repealing the mandate to prefund retiree health remains at the top of NALC's legislative agenda. The mandate, which no other company faces, is responsible for 90 percent of the financial losses incurred by the Postal Service since 2007.

In the House, H.R. 2382 continues to gain bipartisan momentum and has surpassed the "House Consensus Calendar" threshold of 290 cosponsors, which means that the bill can now be placed in the queue for a House floor vote. Under House rules, once a bill is placed in this queue, the Committee of jurisdiction (in this case the Committee on Oversight and Reform) has 25 legislative days to take action on the measure. If no action

President's Article (Continued from page 2) is taken, the bill becomes eligible for a floor vote. As of today, the House bill officially has 294 cosponsors (including 233 Democrats and 61 Republicans), though in actuality that number is 292 cosponsors (232 Democrats and 60 Republicans) due to the resignations of Reps. Chris Collins (R-NY) and Katie Hill (D-CA). This is the time to encourage the House leadership to enact

legislation into law. The union will continue to focus on in-creasing the number of cosponsors on the House bill.

## Formal Step-A Report

During the month of November, 13 grievances were resolved at the Formal Step-A level.

A summary of the settled grievances is listed below:

#### **FORMAL STEP-A:**

- Settled 3 Letters of Warning by getting 1 reduced to a 3month Letter of Warning, 1 reduced to a 4-month Letter of Warning, and 1 reduced to a 6-month Letter of Warning.
- Settled 2 7-Day Suspensions by getting one reduced to a 6 month 7-day suspension and 1 rescinded.
- Settled 3 14-Day Suspensions by 1 getting reduced to an 8-month 7-day suspension and 2 reduced to a 1 year 14-Day suspension.
- Settled 2 grievances where management failed to post vacant bid assignments in a timely manner by getting the successful bidders paid. (Total \$750.00)
- Settled 1 grievance where management worked a carrier outside his regular schedule by getting that carrier paid out of schedule premium. (Total \$576.99)

- Settled 1 grievance where management was performing bargaining unit work by getting a carrier who should have done the work paid (Total \$48.78)
- Settled 1 grievance where management failed to allow a CCA to work the scheduled day of the opt by getting that CCA paid (\$128.00).

During the month of November 7 grievances were appealed to Step B

Management's failure to follow the contract cost the USPS **\$1503.77** this month.

# Contract Talk Vacation Bidding

The 2020 leave year is upon us and the process for bidding annual leave in Tucson should be occurring in your station. The beginning date of the new annual leave year is the first full pay period in the new calendar year. On February 1, 2020 your Union Steward and management should be meeting to determine the leave quota for your station for the upcoming leave year. The leave quota for the Tucson Installation is 12% of the career letter carriers/CCA's on the station rolls as of February 1 of each year.

The Choice vacation period shall begin with the week containing May 1<sup>st</sup> and remains for a period of (52) consecutive weeks ending with the last full week in April, excluding the (3) three-week period immediately preceding Christmas and the (1) one-week period containing Christmas. This (4) four-week exclusion period surrounding Christmas is considered a non-choice period in which leave shall be at the discretion of management. Management may accept Choice Vacation bidding leave submissions beginning February 1, 2019 and leave applications for choice vacation bidding must be submitted no later than the close of business on March 1, 2020.

Each carrier may make the following selections during the Choice Vacation bidding: (1) One 5-day period or two 5-day periods (2) One 10-day period (3) One 10-day period and one 5-day period (4) One 15-day period. No employee may select three separate five-day periods prior to the established deadline. No employee may be scheduled in excess of entitled choice selection leave if such scheduling deprives another employee of an entitled choice during the choice selection period. Scheduling of annual leave for the Choice Vacation Selection period shall be by

bidding seniority/relative standing within each unit. Employees ineligible by seniority for their choice selection(s) shall be consulted and allowed another choice before scheduling junior employees for annual leave during the choice selection period. Submission for Annual leave will be done in triplicate on PS Form 3971. The second copy of Form 3971 will show the action taken (approved/disapproved) and be returned to the employee no later than April 1st. Requests for annual leave for full week leave periods, after the completion of the Choice Vacation Selection period, are limited only by the individual employee's leave balance and the leave (%) quota. These nonchoice submissions begin each April 1st and may be submitted up to the close of business of the Tuesday prior to the affected service week. This was extracted from the Tucson Local Memorandum of Understanding. Associate Offices please check with your Local Memorandum of Understanding.

In Union Solidarity, JC Mena Sun Union Steward

By making a contribution to the Letter Carrier Political Fund, you are doing so voluntarily with the understanding that your contribution is not a condition of membership in the National Association of Letter Carriers or of employment by the Postal Service, nor is it part of union dues. You have a right to refuse to contribute without any reprisal. The Letter Carrier Political Fund will use the money it receives to contribute to candidates for federal office and undertake other political spending as permitted by law. Your selection shall remain in full and effect until cancelled. Contributions to the Letter Carrier Political Fund are not deductible for federal income tax purposes. Federal law prohibits the Letter Carrier Political Fund from soliciting contributions from individuals who are not NALC members, executive and administrative staff or their families. Any contribution received from such an individual will be refunded to that coordinator. Federal law requires us to use our best efforts to collect and report the name, mailing address, occupation and name of the employer of individuals whose contributions exceed \$200 in a calendar year.



## **Health Benefit Report**

#### **Steroids May Hurt Joints**

Steroid injections for an aching knee or hip joint may ease pain, but a recent report says the treatment could trigger or speed up osteoarthritis progression and con-tribute to joint destruction and bone loss. If you're considering the shots, researchers recommend discussing the possible risks with your doctor. Source: Radiology, Oct. 15, 2019, online

#### **Healthier Gums, Better Blood Pressure**

Here's another reason to take care of your gums. A recent British review of 81 studies found that in several of them, people with moderate to severe gum disease had 22 to 49 percent higher odds of having high blood pressure than people with healthy gums. If you have gum disease, getting it treated may lower your numbers, researchers say. In 5 of 12 studies, doing so reduced systolic blood pressure (the top number) by three to 12 points and diastolic pressure by up to 10 points. Gum-disease bacteria may increase inflammation, which can reduce blood vessel flexibility. That in turn may boost blood pressure.
