While I try to stay as positive as possible I am absolutely **disgusted** and **repulsed** by a recent decision made by management regarding a not-at-fault accident. The accident happened at Fort Lowell station involving one of our active 40-year veteran letter carriers. In a nutshell, the carrier was leaving the station and in the only lane to exit the station, a postal customer was dropping off mail in the blue collection boxes and drove over the curb to enter the lane exiting the station to try to get in front of the

LLV that was already stopped in the lane. In doing this the customer hit their back bumper on the completely stopped LLV's front end causing the customer's plastic bumper to be pulled off. What did management do to reward the carrier for doing everything safe you ask? Well of course this senior carrier was issued an emergency suspension and placed in an off-duty status with no pay and subsequently issued a 7-day suspension. I have to ask how any carrier can have any respect for this type of decision maker in the USPS. **Shame! Shame!**

Everyone seemed enthusiastic about the November mid-term elections in Arizona. There was a sense of momentum that we can and will make a difference with our votes for the betterment of workers if everyone votes and a comradeship being around union members of all different crafts and trades. If you have not had the opportunity to go to a Labor picnic I hope you try to come to the next one.

Everyone should have gotten a NALC election ballot in the mail and sent them back by the time you read this newsletter. We should have the results sometime in October.

Have you noticed your paystub and seen the \$645.00 per year COLA raise? Thankfully, our union has fought hard to keep COLAs in our contract. On November 24th, 2018 we will also see an increase to grade 2 for all career carriers and a 3.1% increase for all CCAs. I am so glad we have a strong union that looks after us to make sure we get a fair day's wage for a fair day's work otherwise if it was up to management we would still be waiting.

I want to remind everyone of our first branch event for Muscular Dystrophy, the Muscle Walk is on September 29, 2018 at Reid Park. Our National Business Agent for Region 4, Roger Bledsoe, will be in Tucson to participate with us and help kick it off. Branch 704 MDA Coordinator, Israel Silva, put this in motion and is his first event. I encourage everyone to participate in the walk by joining our NALC704 team or by sponsoring someone on the team by going musclewalkmda.org/tucson and help make this a success. Your donation is tax deductible and goes to such a great cause.

I know we are getting into our busiest time for the post office and we will be getting a lot of mail and parcels not only for the elections but also the holidays coming up. The post office has done some hiring of new CCAs but whether there will be enough CCAs to go around Tucson is still a wait and see situation. Let's make sure

if management continues to force 8-hour employees and work assignment employees off their assignments that you are informing your shop steward, so they can make sure management is following the contract. Even though we go through this issue every year your shop steward does not know everything that happens in your station, they need your help keeping them informed of what is going on. Don't just assume someone else has already told your steward what is happening; let them know and help them to enforce your rights under the National Contract.

The position of Tucson Postmaster had not been filled because Bill Schwartz has been on a detail, and John LaFreniere had been Acting Postmaster during his absence. This month John LaFreniere was named as Tucson Postmaster, so when you see him tell him congratulations.

Stay safe at work, let's make sure we go home healthy to our families and loved ones.

Formal Step-A Report

During the month of August, 56 grievances were resolved at the Formal Step-A level.

A summary of the settled grievances is listed below:

FORMAL STEP-A:

- Settled 1 Letter of Warning by getting it reduced to Time served.
- Settled 1 7-Day Suspension by getting the 7-Day Suspension reduced to an 8-month L.O.W.
- Settled 1 14-Day Suspension by getting the 14-Day Suspension reduced to a 15-month 14-day suspension.
- Settled 1 grievance where management moved a T-6 off their assignment for the day without bringing in the regular carrier by getting that T-6 paid (Total \$140.33).
- Settled 3 grievances where management failed to allow carriers to work the Schedule and hours of the opt by getting those carriers paid (Total \$412.93).
- Settled 49 grievances where management improperly forced non-ODL carriers to work overtime by getting those carriers paid the appropriate premium payment and the ODL carriers paid for the missed opportunities (Total: \$8,239.01).

We received 2 Step B decisions back this month: The grievances were sustained in the union's favor for management not posting vacant routes within 14 days. The B team awarded a monetary remedy of \$150.00 and \$200.00 dollars.

Management's failure to follow the contract at the Formal A cost the USPS \$9,142.27 this month.

Management's failure to follow the contract at the Informal A cost the USPS \$20,912.41 this month.

Total \$ 30,054.68

There are 38 grievances outstanding at Formal Step-A.

How to Reduce Arthritis Pain

Only 41 percent of men and women age 65 or older who are overweight or obese and have arthritis are getting an important piece of advice from their doctor: Drop some pounds. That's the conclusion of a recent study of 1,802 adults in the U.S. Weight loss reduces the pain and mobility problems related to arthritis, and its effects can be significant; every pound you lose takes 4 pounds of pressure off your knees. Do Brain-Training Games Really Help?

You may have heard that computerized "brain training" games can help to stave off cognitive decline. But a number of studies haven't found them to be very useful. "Brain training can be beneficial, but really only for the task you're specifically being trained for—for example, if you train a group of seniors on how to better memorize a supermarket list, they will generally improve, but they won't be able to remember faces any better," says UCLA's Zaldy Tan, M.D. Instead, participate in intellectually challenging

and interesting activities that are new to you, such as learning to paint. "Whenever we learn something that's completely novel to us, we form new brain connections," Tan says. Even inconsequential activities can bring real benefits. A large Chinese study of people 65 and older, published in JAMA Psychiatry this past May, found that those who regularly participated in intellectual activities such as reading books or newspapers, and playing board games, card games or mahjong, had a significantly lower risk of dementia over seven years of follow-up. Keep up social activities too.

"Social isolation is another risk factor for dementia," Tan says. Volunteering is a good option. Older adults who do so have a lower risk of dementia, according to a study published last year in PLOS One.
