Delegates from across our great country exercised one of our most basic union rights by voicing their opinion on many resolutions that will guide us into the future. We had several guest speakers not only from other labor unions but also from both democratic and republican sides of the house. Delegates attended some excellent training classes before and after the general convention sessions covering retirement, TSP, contract administration, safety and health, mutual benefits and many more. In addition, in accordance with Article 6 of the NALC Constitution, nominations for all National officers and fifteen National Business Agents were conducted on Wednesday from the floor. Ballots will be mailed beginning September 11<sup>th</sup> for all contested positions to every active and retired member. Please make sure to exercise your right to vote by returning your ballot by the deadline. Our National officers and staff deserve a huge letter carrier cheer for all the hard work they put in making the 2018 National Convention a huge success. #### **National Level Settlements**

Great news! If you are a former TE or CCA, or a CCA during the backpay period of the 2016-2019, or a CCA with 30 months as of September 1, 2018, you will want to take a look at National level settlements M-01896, M-01895, M-01894, and M-01892. These settlements cover errors in TE step credits, delays in retroactive pay for CCAs, CCA holiday pay, and CCA conversions to career status. In addition, M-01893 addresses the "hold in place" rule that applied to promotion pay for carriers who were promoted prior to the ELM revisions. ## **Vice President Article**

Dear Brothers and Sisters,

The NALC 71<sup>st</sup> Biennial Convention in Detroit was fantastic. We had great speakers, classes, and best of all, President Rolando speaking to delegates about the many difficulties facing letter carriers. He spoke about the elections, that they have consequences such as,

- The appointment of Supreme Court Justice Neil Gorsuch who helped lead to the negative decision in the Janus vs AFSCME case.
- The \$2 trillion tax cut that is ballooning the federal budget deficit and exposing federal employees' jobs, pay and benefits to potential cuts.
- Executive orders are harming workers with the loss of overtime provisions and are gutting federal employees' union rights.

It was not a surprise when President Rolando told us about the creation of an administration task force to develop ways to "restructure" USPS and examine the definition of universal service. We will have to fight even more to keep what we have and not lose any of our hard-won benefits including our jobs. I encourage everyone if they want to read more about what our president had to say go to www.nalc.org and click on convention highlights.

We carriers are fortunate that we have really dedicated union officials that work for us from President Rolando all the way to our stewards at the stations. When we stand together we can persevere and win, so while we have some hurdles to overcome. I also see this as opportunities for our leaders to come up with solutions. But they cannot do this without all of us supporting them and putting our money to work. If you have not signed up with Letter Carrier Political Fund (LCPF) this is the time to be active and support our union cause. Branch 704 President Dan Versluis was nominated for National Business Agent for Region 4 along with Anita Lewallen, from Conway AR Branch 1592. Ballots will be sent out to all union members in region 4 for everyone to vote, so make sure to keep an eye out for the ballots and VOTE.

District Safety will be pushing rollaway / runaways. While this may not be the majority of our accidents it is the most dangerous and expensive both in lives and money. So please make sure you are working safe, put the hand break ON and Pull the keys out, if your tush is off the seat. I want you to go home the same as you came in to work, for your family and co-workers who depend on you to be at work the next day.

#### Letter Carrier Political Fund By making a contribution to the Letter

By making a contribution to the Letter Carrier Political Fund, you are doing so voluntarily with the understanding that your contribution is not a condition of membership in the National Association of Letter Carriers or of employment by the Postal Service, nor is it part of union dues. You have a right to refuse to contribute without any reprisal. The Letter Carrier Political Fund will use the money it receives to contribute to candidates for federal office and undertake other political spending as permitted by law. Your selection shall remain in full force and effect until cancelled. Contributions to the Letter Carrier Political Fund are not deductible for federal income tax purposes. Federal law prohibits the Letter Carrier Political Fund from soliciting contributions from individuals who are not NALC members, executive and administrative staff or their families. Any contribution received from such an individual will be refunded to that contributor.

### NALC BRANCH 704 PROPOSED BY-LAWS CHANGE

**Current language:** 

#### ARTICLE VIII FUNDS AND BUDGET

#### Section 4

(Effective 01/01/2003) Two percent (2%) of all dues collected by the branch shall be set aside in a separate fund called "The State Convention Fund". This fund shall be used to offset the cost to the Branch and members attending any State Convention, all amounts to be decided by the Executive Board. This fund may not be used for other purposes except by a two-thirds (2/3) majority vote of members present at a regular branch meeting.

#### Section 5

(Effective 01/01/2003) Six percent (6%) of all dues collected by the branch shall be set aside and placed in a separate fund called "The National Convention Fund". This fund shall be used to offset the cost to the Branch and members attending the National Convention, all amounts to be decided by the Executive Board. This fund may not be used for other purposes except by a two-thirds (2/3) majority vote of members present at a regular branch meeting.

#### Proposed language: (Changes in bold)

#### ARTICLE VIII FUNDS AND BUDGET

#### Section 4

**One and a half** percent (**1 1/2**%) of all dues collected by the branch shall be set aside in a separate fund called "The State Convention Fund". This fund shall be used to offset the cost to the Branch and members attending any State Convention, all amounts to be decided by the Executive Board. This fund may not be used for other purposes except by a two-thirds (2/3) majority vote of members present at a regular branch meeting.

#### Section 5

Six **and a half** percent (6 **1/2**%) of all dues collected by the branch shall be set aside and placed in a separate fund called "The National Convention Fund". This fund shall be used to offset the cost to the Branch and members attending the National Convention, all amounts to be decided by the Executive Board. This fund may not be used for other purposes except by a two-thirds (2/3) majority vote of members present at a regular branch meeting.

## **Formal Step-A Report**

During the month of July, 35 grievances were resolved at the Formal Step-A level. A summary of the settled grievances is listed below:

#### FORMAL STEP-A:

- Settled **1** Letter of Warning by getting it reduced to a 3-month L.O.W.
- Settled **1** 7-Day Suspension by getting the 7-Day Suspension reduced to 1-year L.O.W.
- Settled **2** grievances, management improperly forced non-ODL carriers to work overtime by getting those carriers paid the appropriate premium payment and ODL carriers paid for the missed opportunities (**Total: \$659.04**).
- Settled 2 grievances, management was performing bargaining unit work by getting those carriers who should have done the work paid (Total \$266.86).
- Settled **1** grievance, a Steward had to process grievances off the clock by getting that Steward paid (Total \$400.31).
- Settled 2 grievances, management failed to post vacant bid assignments in a timely manner by getting the successful bidders or assigned carriers of


those routes paid \$250.00 each. (Total \$2,000.00).

- Settled **4** grievances where RCAs were performing City Carrier work delivering Amazon parcels by getting the carriers who should have done the work paid. (**Total \$1,666.69**).
- Settled **1** grievance where management denied two days of COP to a carrier by getting that carrier paid **(\$284.48)**.
- Settled **21** Quarterly overtime grievances where management failed to equalize the overtime hours and opportunities by getting the effected OTDL carriers paid for missed opportunities. (Amount not reported by agreement.)

## Management's failure to follow the contract cost the USPS \$ 5,227.38 this month.

There are 27 grievances outstanding at Formal Step-A.

### Health Benefit Report Sun Safety Smarts

When you purchase a product designed to shield your skin from the sun's damaging rays, you expect that it will perform as promised, but that might not always be the case.

The Food and Drug Administration recently announced that it would be more closely scrutinizing products claimed to protect you from the sun.

The agency's first step was cracking down on four dietarysupplement companies. According to the FDA, the manufacturers make claims that give "...consumers a false sense of security that a dietary supplement could prevent sunburn, reduce early skin aging caused by the sun, or protect from the risks of skin cancer." The FDA also said it would address "the effectiveness of various SPF values."

For several years in a row, Consumer Reports has found that for many sunscreens the SPF (sun protection factor) value in our testing isn't consistent with the SPF on the package. (CR's tests vary slightly from those the FDA requires manufacturers to do.) This year, we found 24 out of 73 sunscreens that tested at less than half their labeled SPF. (Trader Joe's Spray SPF 50+, got an Overall Score of 100 in our tests, earning Excellent scores for UVA and UVB protection, and variation from SPF.)

William Wallace, senior policy analyst for Consumers Union, the advocacy division of CR, says he hopes the FDA's statement indicates that the agency will do more to help consumers trust that they're getting what they expect from sunscreen. "The FDA should set a high bar," he says. For more information on getting the most from your sunscreen, go to CR.org/sunsmart
